

**BREEDING CONTRACT FOR SR
HALLMARKED**

I hereby agree to breed my mare

Reg No. _____
to SR HALLMARKED during the 2007
breeding season. I understand the stallion
will be standing at Bob Kurtz Performance
Horses in Boyd, Texas. If shipped semen is
preferred, he will be collected and semen
will be shipped by a Fort Worth-area stallion
station.

I agree to pay Bob Kurtz the sum of
\$2,000 (\$1,000 if one of first 20 mares to
send in \$500 deposit) as the full breeding
fee. Of this amount, \$500 will be a booking
fee and must accompany this contract when
it is returned. The balance will be due and
payable at the time the mare leaves the
breeding farm or semen is shipped.

All veterinary expenses, including
shipped semen, collection of the stallion,
cooled semen, mare care and board and
any other veterinary expense will be billed
separately and paid by the mare owner
before the mare and foal leaves the
breeding facility.

It is further agreed that should the
above-named stallion die or become unfit for
service, or if my mare should die or become
unfit to breed, then this contract shall
become null and void and any money paid
as part of this service shall be refunded to
me.

It is my understanding that you will
exercise your judgment in caring and
supervising for my mare. However, neither
the stallion owner nor any employee of the
stallion facility will be responsible for
accident, sickness or death to my mare or
foal, whether from fire, flood, theft, sickness,
act of God or any other reason. Likewise, I
will not be responsible for any disease,
accident or injury to your stallion or mares
for any reason. In the event of any injury or
death to my animal, I will look solely to my
own insurance.

It is agreeable for your veterinarian
to check my mare for normal breeding
conditions and to perform such other
veterinary services as you deem necessary
or we agree on.

If for any reason the mare does not
settle, I will hold the stallion owner harmless.
It is also agreed that the stallion owner
guarantees a live foal to the owner of the
mare at the time of the signing of this
contract and if the mare is not in foal or if
the foal does not stand and suck, I will be
entitled to a free season the following year

to the same mare, unless mutually agreed
that a different mare can be used. This
guarantee applies only if the stallion owner
is notified within 10 days after the death of
the foal. The free season shall refer to the
breeding fees only, with board and vet
expenses being charged as usual.

Mares brought to the breeding farm
must be halter broke, accompanied by a
current health certificate and current
negative Coggins test. She must also be
current on tetanus, influenza, sleeping
sickness, rhinopneumonitis and West Nile
virus vaccinations.

A copy of the mare's registration
certificate, both sides, thereof, must be
furnished with this contract.

It is agreed that if it should become
necessary for you or someone on your
behalf to incur costs and expenses to retain
the services of any attorney, pay legal fees
and/or court costs to enforce this agreement
or any portion thereof, I agree to pay
reasonable costs and attorney fees thereby
expended.

It is expressly agreed that this
contract is performable in Wise County,
Texas, and venue for any action hereunder
shall be in Wise County, Texas.
